11.1 <u>Measure R: Change Orders 6A, 4C, 7D, and 4E - Modular Classroom Projects</u>: Ms. Cheryl Demeyer from Cumming Group, presented the change orders in connection with the replacement the oldest portables located at Fammatre, Farnham, Sartorette, and Price Middle School.

Correction: The Galeb Paving Change Order #6A, is a credit of \$203,280.00, instead of the listed \$160,306.16 credit on the agenda item.

ACTION: On a motion by Trustee Middleton, seconded by Trustee Presunka, the Board ratified the four (4) necessary change orders; 6A, 4C, 7D, and 4E, in connection with the Modular Classroom Projects and the revised amount of the total credit to \$335,461.16. Motion **CARRIED** 5-0

11.2 <u>Measure R: Resolution 24-25-05 - Declaring the Futility of Public Bidding for Site Concrete Trade Services for</u> <u>Increment 1 Sitework for Modular Classrooms at Fammatre, Farnham, Sartorette, and Price Middle Schools</u>: Ms. Cheryl Demeyer from Cumming Group, presented the resolution. The resolution will allow the District to continue with McGuire and Hester (formerly named Casey-Fogli Concrete at the time of bid) to complete the current project in process with the 14.51% increase over the original contracted amount due to the required accessibility (ADA) upgrades for state certification.

- 11.4 <u>Curriculum & Instruction: English Learner Program Update</u>: Mr. Linh Nguyen, Assistant Superintendent of Educational Services, provided an update on the English Learner Program. He reviewed Cambrian's goals and the programs overall achievement for the 383 English Learner students. Mr. Nguyen also highlighted the programs and services we offer.
- 11.5 <u>Budget: First Interim Report 2024-25</u>: Chief Financial Officer, Dr. John Pappalardo, presented the first interim report for Board certification as required by Education Code Sections 35015 and 35035 (g). Dr. Pappalardo shared the general fund assumptions and highlighted the unrestricted and restricted revenues and expenditures. The Board had an opportunity to review the report to ensure the District will be able to meet its financial obligations through June 2025.

ACTION: On a motion by Trustee Gillis, seconded by Trustee Middleton, the Board approved the first Interim Report, found that the District will be able to meet its financial obligations through June 30, 2025, and the two subsequent fiscal years, authorized the Board President to certify and file a "positive" financial certification statement with the Santa Clara Office of Education. Chief Financial Officer, Dr. John Pappalardo, presented an overview of the committee and development criteria to ensure the District remains fiscally solvent and protects high-quality classroom experiences for our students
