## 6. ANNOUNCEMENTS

- 6.1 Mrs. Presunka wished everyone a Happy New Year and announced that the 2022-23 Registration Open Enrollment opens on Monday, January 24, 2022 and runs through March 1, 2022.
- 6.2 Ms. Schwiebert shared that Cambrian is excited to bring new families to Cambrian during the Open Enrollment window. She announced that the Transitional Kindergarten age window has been expanded to accommodate students who are turning 5 up to February 2.

This past Sunday, staff passed out 1,800 antigen tests to our community in order for students to test prior to returning back to school. Ms. Schwiebert thanked Bev Merrell, Linh Nguyen, Michael Kretsch, Amy O'Hehir, Samantha Haley, Henry Cervantes, and Janet Gillis, for joining her at the last minute to dispute the tests.

Ms. Schwiebert thanked the Principals and staff for their continued flexibility in navigating all the changes in requirements of COVID-19.

Ms. Schwiebert expressed her sincere appreciation to the Cambrian teachers for always going above and beyond to help students. Teachers have increased their independent studies work load to ensure students who are isolated at home are able to continue with class assignments.

Tom Carroll Jr expressed his opposition to COVID vaccines and booster shots. Mr. Carroll encouraged the Board to allow students to have the option to wear masks or test if they choose.

He comes to us with decades of experience, as a former superintendent and Chief Executive Officer. Dr. Pappalardo will easily be able to step in and will be a wonderful addition to our team.

8.3 Measure R: Portable Replacement Project Placement for Fammatre, Farnham, Sartorette, and Price: Ms. Schwiebert and the Board of Trustees had the opportunity to discuss the placement for the new portables at Fammatre, Farnham, Sartorette, and Price as part of the Measure R Tier I projects; Phase 2 & 3 Modernizations.

### **Public Comments:**

Wojtek Poppe shared his concerned over the removal of some of trees at Farnham Elementary School if the portables are placed in the proposed spot.

Harpreet & Harshdeap Keith expressed their concern regarding the placement of portables at Farnham. They shared the importance of the current tree grove and encouraged the Board to reconsider the placement of the portables.

**ACTION:** On a motion by Mr. Scofield, seconded by Mr. Rocha, the Board approved the suggested placement of the portables at Fammatre, Farnham, Sartorette, and Price with the intention to reestablish the tree grove at Farnham. Motion **CARRIED** 5-0
