Ms. Schwiebert highlighted Sartorette's Earth Day Beautification. It was a wonderful time for children to learn the value of family time and community service while helping with landscaping and gardening around the campus.

# 8. PUBLIC COMMENTS

Rick Schertle, Steindorf Teacher, highlighted Steindorf's first annual Marker's Fair and shared how these amazing experiences would not be possible without Cambrian's amazing teachers. He encouraged the Board to prioritize teachers in the District's budget.

Raycelle Fordham, Cambrian Teacher, shared with the Board that she no longer feels valued as a Cambrian teacher. She requested the Board to make the hard decisions to prioritize teachers and pay Cambrian teachers what they are worth.

Angela Kochiyama, Cambrian Teacher, encouraged the Board to the make necessary adjusts to the budget in order to prioritize teachers.

Sam Shiraishi, Bagby Parent, asked the Board to show the teachers how much they are valued by making them a priority and increase their salaries.

Kerri Lauck, spoke on behalf of another Cambrian Teacher, the teacher requested the Board to show the teachers that are valued by prioritizing them in Cambrian's budget.

Joanne Grigore, Price Teacher, expressed her frustration that Cambrian teachers are not at the top of the budget list and deserve a raise for all their sacrifices over the last three years.

John Olsen, Price Teacher, encouraged the Board to do something now to prioritize teacher in Cambrian's Budget.

Meliss Ojczyk, Cambrian Parent, encouraged the Board to make the hard discussions and prioritize the District Budget.
